#### **CALL TO ORDER**

PD/GWSS Board Chairperson Al Rossini welcomed everyone to the meeting. Chairperson Rossini presented Certificates of Appreciation to former Board member Frank Leeds and outgoing Chairperson Herb Schmidt. He thanked them both for their dedication and hard work in the fight against Pierce's disease and the glassy-winged sharpshooter. Napa County Agricultural Commissioner David Whitmer welcomed all members and attendees. He commended the Board, the ATF, and Pierce's Disease Control Program. ### **FISCAL UPDATE**

Bob Wynn reviewed the program's Operations Revenue and Expenditure Report. Tom Esser discussed the Board's Revenues and Expenditures.

Beth Stone-Smith then presented the federal budget and FY 09 detail updates for the USDA. She noted that the original Omnibus appropriations amount was for \$22.948 million but was reduced to \$22.518 million. They were still waiting for the official and final amount.

### **PIPRA UPDATE**

Alan Bennett gave an update on Public Intellectual Property Resource for Agriculture's (PIPRA) PD/GWSS activities. Alan noted that they continued to facilitate the pipeline on research projects. Major accomplishments included: consolidation of information and databases into a web-portal; development of an IP policy; and development of regulatory strategies for GM grapevines and rootstocks. Alan noted they would be consulting with Dr. Scott Thenell regarding USDA regulatory applications for permits for future GMO field trials and testing for grapevine and rootstock research projects.

### **PIPRA PROPOSAL**

Tom Esser led the discussion on the two-year PIPRA proposal submitted for the Board's approval. This proposal would include the continued maintenance of the PD intellectual property literature database and portal, working with USDA on regulatory permits related to field trials on GM rootstock and grapevines research, development of a standardized regulatory process for GM rootstocks and grapevines, and a pre-marketing survey on PD strategies deployment to be sent to the grape industry. The Board's only concern was the survey segment of the proposal and the types of questions the survey would contain. The Board and ATF wanted to be actively involved in the process and had concerns on how to approach industry members regarding such a survey. The Board formed a subcommittee consisting of Herb Schmidt, Nancy Irelan, Greg Coleman, Steve McIntyre, Brad Lange, Tom Esser, and industry representative Camron King that would work with PIPRA on the survey.

- It was moved, seconded, and passed unanimously by the Board to recommend renewing the service contract with the Public Intellectual Property Resource for Agriculture (PIPRA; located at UC Davis), to continue providing support for the management of intellectual property within the Pierce's disease research initiative and research community. The service contract is for \$112,250 for FY 2009-10 and \$113,875 for FY 2010-11.

### **RESEARCH PROPOSAL BY DR. RICK REDAK**

Bob Wynn discussed the research proposal provided by Dr. Rick Redak for evaluating four additional materials for use as approved treatment insecticides for nursery stock. The four materials are deltamethrin, acetamiprid, spirotetramat, and spinetoram.

- It was moved, seconded, and passed unanimously by the Board to recommend funding the research proposal entitled, "Evaluation of Additional Insecticides for Quarantine Against the Glassy-winged Sharpshooter in California's Commercial Ornamental Nurseries," by Dr. Rick Redak. The total amount of the contract is \$143,435.

### **RESEARCH FUNDING RECOMMENDATIONS**

Tom Esser discussed the CDFA PD/GWSS Research Screening Committee funding recommendations. Out of 27 proposals submitted, 13 were recommended for funding. Of these, 11 would be funded by the UC-PD program using funding provided by USDA-CSREES. It was recommended that the Board fund the remaining two. These were submitted by Drs. Bruce Kirkpatrick and Andy Walker and total \$806,570 over three years.

- It was moved, seconded, and passed unanimously by the Board to recommend funding the following two research projects, totaling \$806,570 over three years: Dr. Bruce Kirkpatrick, "Identification and Utilization of Cold Temperature Induced Grapevine Metabolites to Manage PD," total cost \$218,570 and Dr. Andy Walker, "Breeding PD Resistant Winegrapes," total cost \$588,000.

Beth Stone-Smith provided an update on the GWSS areawide programs in Riverside County (Temecula and Coachella Valley), Kern County (General Beal, North Zone, and Hwy 65), and Tulare County.
